## 1. FOREWORD

- 1.1. Gulf Historic Formula One From 1985 to 1999 (hereafter referred to the “Demonstration”) will be held in the Event « Gulf Historic Dubai GP Revival » (hereafter referred to the “Event”), a national status event that will be run in accordance to the EMSO National Sporting Code and incorporating the FIA International Sporting Code. The Competition is open to one to two drivers team (Maximum two drivers sharing the same car during the whole event).
- 1.2. Gulf Historic Formula One From 1985 to 1999 Sporting Regulations (hereinafter referred to as the “Regulations”) are governed by Federation Internationale de l’ Automobile (FIA) Sporting Code (hereinafter referred to as “the Code”) and its Appendices (particularly to Appendix J & K for cars from 1985 to 1999, Circuit General Prescriptions; the specific Technical Regulations in period and their relevant Appendix, Event Bulletins and all the communications or final instructions issued by the Organizer and Promoter and in accordance with the national motor sport conditions at the prevailing period of time. All organizations that participate in the Competition (including but not limited to EMSO, Promoter, Competitors and Circuits) must adhere to the regulations.
- 1.3. Articles 2.1.13 of Appendix K require special consideration on the part of the Competitors.
- 1.4. The final text of these Sporting Regulations shall be the English version approved by the EMSO is binding and which will be used should any dispute arise as to their interpretation.
- 1.5. These Regulations have been approved by the EMSO. under Organization permit EMSO -2023 - 331 Gulf Historic Formula one 1985 to 1999.

## 4. ELIGIBLE CARS

- 4.1. All vehicles must comply with the requirements noted in the Appendix K relevant to the appropriate category.
- 4.2. These Regulations have been approved by the EMSO. under Organization permit EMSO -2023 - XXX Gulf Historic Formula one 1985 to 1999.
- 4.3. All cars built to the appropriate Formula One regulations from 1985 to 1999 running in their original specification which are eligible.

## 5. ELIGIBLE DRIVERS AND COMPETITORS

To be eligible to compete in the Competition, each Driver must:

- 5.2. Hold of a current and valid FIA International Licence (See 2023 FIA Appendix L).

- Four 20-minute Demonstration;

## 9. ENTRIES

- 9.1. The Entry Form must be completed before 31 October 2023.
- 9.2. The application submission can be completed at [www.gulf-historic.com](http://www.gulf-historic.com).
- 9.3. Each application dossier must be accompanied by:
  - a) The Entry for the Demonstration is euros (€) 2,000 excluding 5% VAT. In case of Force Majeure with valid documentation, no charge will be made for cancellation until the 4th of October 2023. After this date, the entry fee will serve as credit for the 2024 event.

  - b) All vehicles must comply with the requirements noted in the Appendix J relevant to the appropriate period.
  - c) A copy of the Driver's Competition Licenses;
  - d) A copy Driver's authorizations from ASN for the Event
  - e) A copy of the Driver's medical certificate.
- 9.4. The Organizer will review the eligibility of each application and reserves the right to refuse the application without having the obligation to provide any explanation. The decisions taken by the Organizer are final and not subject to appeal.

### 13. GENERAL SAFETY AND DISCIPLINE

13.5. Refuelling is strictly forbidden during the Demonstration.

### 14. ADMINISTRATION CHECKS AND SAFETY EQUIPMENT CHECKS

14.6. The Competitors must nominate the official crew comprising a maximum of 2 drivers per car.

## APPENDIX 1 : REMINDER - 2023 ISC - ARTICLE 6 DEMONSTRATION

### ARTICLE 6.1 CONDITIONS

The following conditions must be observed:

**6.1.1** *Demonstrations* are controlled at all times by the

clerk of the *Course*;

**6.1.3** all the marshals must be present at their posts (within the framework of an *Event*), and rescue and signalling services are required;

**6.1.4** arrangements ensuring the safety of the spectators must be in place;

**6.1.5** *Drivers* must wear appropriate safety clothing (*FIA* approved clothing and helmets are strongly recommended). *Organisers* may specify minimum clothing standards;

**6.1.6** the *Automobiles* must pass scrutineering on safety grounds;

**6.1.7** a precise *Entry* list must be published after scrutineering;

**6.1.8** No passengers are allowed except when the *Automobiles* were originally designed and equipped to transport passengers in the same safety conditions as the *Driver*, and provided that they wear appropriate safety clothing (the clothing and helmets approved by the *FIA* are strongly recommended). The *Organisers* may specify minimum clothing standards;

**6.1.9** overtaking is strictly forbidden unless under the instructions of marshals showing blue flags;

**6.1.10** timing is forbidden;

**6.1.11** Within the framework of an *Event*, any *Demonstration* must be mentioned in the *Supplementary Regulations* and the *Automobiles* taking part must be mentioned in the *Official Programme*.

### ARTICLE 6.2 AUTHORISATION

*Demonstrations* cannot be organised without express authorisation from the *ASN* of the organising country
